**CONTEST RULES AND GUIDELINES**

**Create your advertisement around one of these themes:**

- 1. Saving For My Future**
- or*
- 2. Mobile Banking Is Awesome**
- or*
- 3. Young Americans Save Money**



Be creative! We're looking for the **best message about kids and banking**, not the best artist.

**To Enter:** Your ad must be created on an official entry form that includes a parental permission slip. Additional entry forms may be picked up at FNB of Steeleville, Sparta Banking Center or Percy Banking Center. (No computer generated ads will be accepted.) Then, submit your ad to any bank location by close of business, April 10, 2020. Ad guidelines are as follows:

1. Pick **one** of the subjects **listed above.**
2. Obtain an official entry form marked with ad size boundaries. Stay within the lines. (Must use 28 lb paper. Ask for another official entry form if you need to start over.)
3. Create your ad using colored markers and black markers. Fine tip markers are recommended. **NO CRAYONS.**
4. Design should not include copyrighted material such as cartoon characters.
5. **DO NOT** put your name on the ad side of your entry form.
6. Name, school information and parental permission slip must be completed on the reverse side of the form.

**Judging:** Judging will take place the week of April 13, at the Main bank in Steeleville. Ads from all bank locations will be combined for judging within each grade level. Three bank officers will judge the ads according to **creativity, message content and neatness.**

**Prizes:** One winning ad from 3rd, 4th, and 5th grades (a total of three ads) will be published in the County Journal newspaper on April 23, 2020. Winners will receive \$100! **AGAIN THIS YEAR:** *FNB of Steeleville will sponsor a pizza party for the class of each winner! (A total of three pizza parties.) Party plans will be coordinated with schools and teachers after winners are announced.*

**Prize Claim:** Winners will be notified by telephone on or before April 17. We will make arrangements to present the cash prize at that time.

**Other Information:** Need not be a bank customer to enter. Only one entry per child. All ads will be displayed at First National Bank of Steeleville, Sparta Banking Center or Percy Banking Center during Community Banking Week, April 6-10, 2020. Children of First National Bank of Steeleville employees, directors and officers, and their immediate families and their respective household members, whether or not related, are not eligible to enter.
